



## INFORMATION CLAUSE CONCERNING THE PRINCIPLES OF PERSONAL DATA PROCESSING TRANSFERRED FOR THE PURPOSE OF USING THE GENERATOR FOR PERSONAL DATA PROCESSING

Pursuant to art. 13 (1) of the Regulation of the European Parliament and of the Council 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC, (referred to as "GDPR"), home.pl S.A. with its seat in Szczecin at the address ul. Zbożowa 4, 70-653 Szczecin, incorporated into the Entrepreneurs' Register of the National Court Register conducted by the District Court in Szczecin, XIII Commercial Division of the National Court Register under number 0000431335, REGON 811158242, NIP 8522103252 (hereinafter referred to as: home.pl), hereby informs that:

1. The Controller of your personal data is home.pl.
2. home.pl will appoint a data protection inspector within the meaning of GDPR who can be contacted by means of email, to the address: IODO@home.net.pl.
3. Your personal data will be processed on the basis of art. 6 (1) a) - c) GDPR for allowing you or the entity which you represent to conclude the agreement with home.pl on personal data processing with the use of the Internet tool of Personal Data Processing Generator, available on the website <https://support.ionos.ro/generator/> ("Generator"), as well as for performing legal obligations imposed on home.pl, for establishing and defending and seeking claims.
4. For the purpose defined in point 3, home.pl will process your personal data indicated by you in the form of the Generator, in particular, name and surname, PESEL number, TAX ID number, contact data, address of residence or address of company.
5. home.pl is authorized to transfer your personal data to third parties:
  - a. for assuring proper and due performance of the activities defined in point 3. Your personal data will be transferred in the agreed mode after prior concluding of the data processing agreement by home.pl with the entity to which the data is transferred;
  - b. in order to perform the obligations resulting from all applicable law provisions, including – authorized courts, bodies, and institutions.
6. Your personal data, in principle, is not transferred beyond the EEA territory. However, your personal data may be transferred beyond EEA if it is necessary to perform the activities defined in point 3, including where for the performance of the activities, Subcontractors of home.pl who possess seats outside the EEA territory will be necessary.
7. Subject to point 7a, your personal data shall be processed for the period necessary for concluding personal data effectively with the use of the Generator, including for the period necessary to review correctness of the data indicated by you; however, for no longer than 2 (two) months after transferring of personal data by you.
  - a. From the date of concluding of the personal data processing agreement by you, the terms and principles of processing the personal data indicated by you in section 3 above shall govern the agreement and other agreements defining the conditions of using the services of home.pl by you (or by the entity you represent) or the content of proper law.
8. Providing of personal data by you for the purposes defined in section 3 is voluntary.
9. Subject to the limitations resulting from GDPR, other law provisions, and the content of section 10, you have the right of access to your data and to correct, remove, limit the processing, transfer it, lodge an objection as well as the right to withdraw your consent for personal data processing at any time. In order to perform the activities defined in this section, you should contact home.pl to inform them in what way you prefer to transfer your data and, if it is not possible, by electronic message sent to the email address: IODO@home.net.pl.
10. A refusal to express consent to process data, withdraw consent, remove the data, and use other rights defined in section 9 before the completion of the procedure of concluding the personal data processing agreement with the use of the Generator, which will result in excluding or limiting the possibility to process your personal data by home.pl, will cause termination of the procedure of concluding the agreement with the use of the Generator.
11. You have the right to lodge a complaint to the supervision body within the meaning of GDPR, if you recognize that processing of your personal data infringes GDPR provisions.
12. Your personal data will be processed in an automated manner for storing and reviewing the correctness of your data. Nonetheless, it will not result in making a decision based exclusively on automated processing. You may be subject to a decision

based exclusively on automated personal data processing, including profiling, if home.pl is authorized thereto on the basis of provisions of law or on the basis of your prior consent.
